The charges for issuance of personal cheques form/issuance of bank cheques include dispatching the cheques to client's address by recorded delivery. If a foreign/domestic bank charges additional cost of cheque processing, they are added to the respective fee in the Price List. The fees for issuing private cheques include delivering the cheques to the client's address by registered mail.

- 1) The expenses for the foreign USD cheque correspondent are USD 2, a EUR cheque are EUR 3 and a GBP cheque in the amount of GBP 2. We offer this service until February 28, 2025.
- 2) In case of request for issuance of 20 and more pcs of personal cheques is charged fee in the amount CZK 15 per cheque, in case of request for issuance less than 20 pcs of personal cheques is charged fee in the amount CZK 100 per cheque.
